## DEA Disposes of 620,000 lbs. of Medication

The Drug Enforcement Administration (DEA) and nearly 4,500 law enforcement

agencies joined forces on April 26 to dispose of more than 620,000 pounds of unneeded and expired medications in an effort to prevent drug misuse and abuse.

The spring collection event marked DEA's 28<sup>th</sup> National Prescription Drug Take Back Day.

Since its inception 16 years ago, DEA Prescription Drug Take Back Day has helped Americans safely remove nearly 19.8 million pounds of expired, unwanted, or unused medications from their homes. **HC DrugFree has been partnering with the Howard County Police and DEA on national Drug Take Back Days since 2012.**

**On April 26, our site in the Wilde Lake Village Center collected 1,359.5 lbs. (48 bins) of medication as weighed/reported by the Howard County Police.** Sharps collected at our site are not included in the weight.

"We want to thank our state, local, and tribal partners for their continued support of DEA's National Prescription Drug Take Back Day," said DEA Acting Administrator Robert Murphy. "For sixteen years you have continued to show up to protect your communities by helping to remove the threat of medications from falling into the wrong hands. This program would not be possible without the support of our law enforcement and community partners."

## Safe Storage of Meds



HC DrugFree gave away 177 medication storage boxes at the April 26th National Drug Take Back Day event!

These boxes help families safely store prescription and over-the-counter medications, reducing the risk of accidental ingestion and misuse.

If you did not receive a storage box from us, we encourage you to use your own secure location, such as a locked cabinet, drawer, or safe, to store medications safely in your home.
